Before the start of each term Vibe Dance Studios will issue an invoice via email for all fees due.</p> <p>6. Fees are due and payable by the date on the invoice.</p> <p>7. Fees remaining unpaid after 21 days of the date of an invoice will attract an administration charge of \$20 to cover the cost of following up invoice.</p> <p>8. Students will not be able to return to class if fees are not paid, resulting in possible legal action for fees being owed.</p> <p>9. Vibe Dance Studios reserves the right to refuse admission to any students whose fees remain unpaid.</p> <p>10. If you choose to pay by cheque please note that if you have insufficient funds in your account, you will be charged a dishonor fee.</p> <p>11. For any missed classes, Vibe Dance Studios has a No Refund Policy.</p> <p>12. Dance is a physical activity, please note that a degree of physical contact with the instructor and student maybe required for either demonstration or correction.</p> <p>13.
